5-25-75 Tested blowout preventer and 4-1/2" casing to 3800 psi 1/4 hour OK. Perfed 2950-76' with 2 SPF. Displaced hole with 1X KCl water and spotted 500 gallons 15X HCl. Pumped in a 4000 gallon pad frac fluid containing 1X KCl and 10 pounds Gel per 1000 gallons. Pumped in 41,244 gallons treated water, 30,000 pounds 10-20 sand and 10,000 pounds 8-12 sand. BDP 1700, maximum treating pressure 1700, minimum 1400 and average 1500 psi. AIR 64 BPM. ISIP 100. Ran tubing and tagged sand at 3021'. Swabbed and flowed well until 6-4-75 when a 4-1/2" "NC" bridge plug was set at 2940'. Loaded hole with 1X KCl water and tested 4-1/2" casing to 3500 psi OK. Perfed 2900-22' with 2 SPF. Spotted 500 gallons 15X HCl. Pumped in 4000 gallons frac pad containing 1X KCl water and 10 pounds Gel per 1000 gallons. Pumped in 40,000 gallons treated water, 30,000 pounds 10-20 sand and 10,000 pounds 8-12 sand. Maximum treating pressure 2275, average 2250 psi. AIR 63 BPM. ISIP 200 psi. Ran tubing and tagged sand at 2925'. Cleaned out sand to bridge plug at 2940', drilled on bridge plug and pushed bridge plug to 3021'. Tubing, 2-3/8", landed at 2992'. Swabbed well 7-1/2 hours and well kicked off flowing.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
