Ran IES and Density log. Went in ho to circ. and condition for casing.

8/1/75 Layed down dp. Ran and cemented 78 joints, 7", 23# casing to 3101 with 450
sacks, 65/35 poz. mix and 12% gel. Tailed in with 50 sacks Class B and 3% CaCl
1/2# sack cellophane. Plug down 3:15 PM, 8/1/75. Float held, set slips, etc.

8/2 and 8/3/75 - drilling.

8/4/75 Circ. hole. Pulled out of hole for logs. Layed down dp and dc. Ran and
cemented 75 joints, 4 1/2", K-55, LT&C Liner to 5231'. Liner top at 2766'. Cemented
with 300 sacks Blass B, 4% gel, 12 1/2# sack gilsonite and 6% D60. Plug down 12:30 AM,
8/5/75. Float held.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
