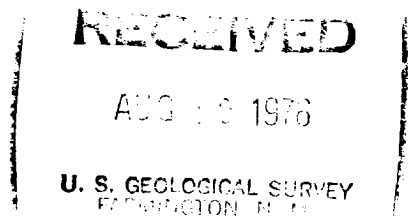
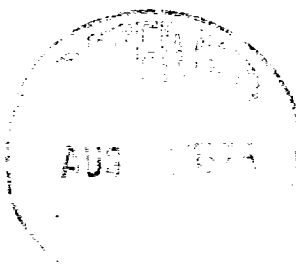

Drilling continued to 3373' where on 6-28-76 the 7" casing was set at 3373' with 750 sacks Class "B" cement followed by 50 sacks Class "B" Neat. Waited on cement to set and tested 7" casing to 800 psi OK. Reduced hole to 6-1/4" and continued drilling to TD of 5510'. On 7-2-76 set 4-1/2" liner from 3192-5506' and cemented liner with 320 sacks Class "B" cement.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
