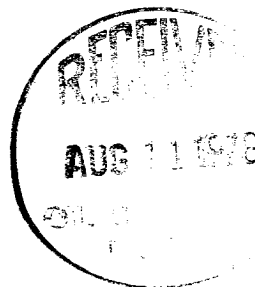

Drilled to 3200' and on 7-7-76 set 7" casing at 3200' with 710 sacks Class "B" cement with 2 pounds Medium Tuf Plug per sack followed by 50 sacks Class "B" Neat. Circulated 80 sacks cement. Waited on cement to set and continued drilling to TD of 5302'. On 7-10-76 set 4-1/2" liner from 2978' to 5301' and cemented with 320 sacks Class "B" cement. The cement circulated. Tested casing with 2600 psi 1/4 hour OK.

## Instructions

**General:** This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

**Item 4:** If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

**Item 17:** Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
