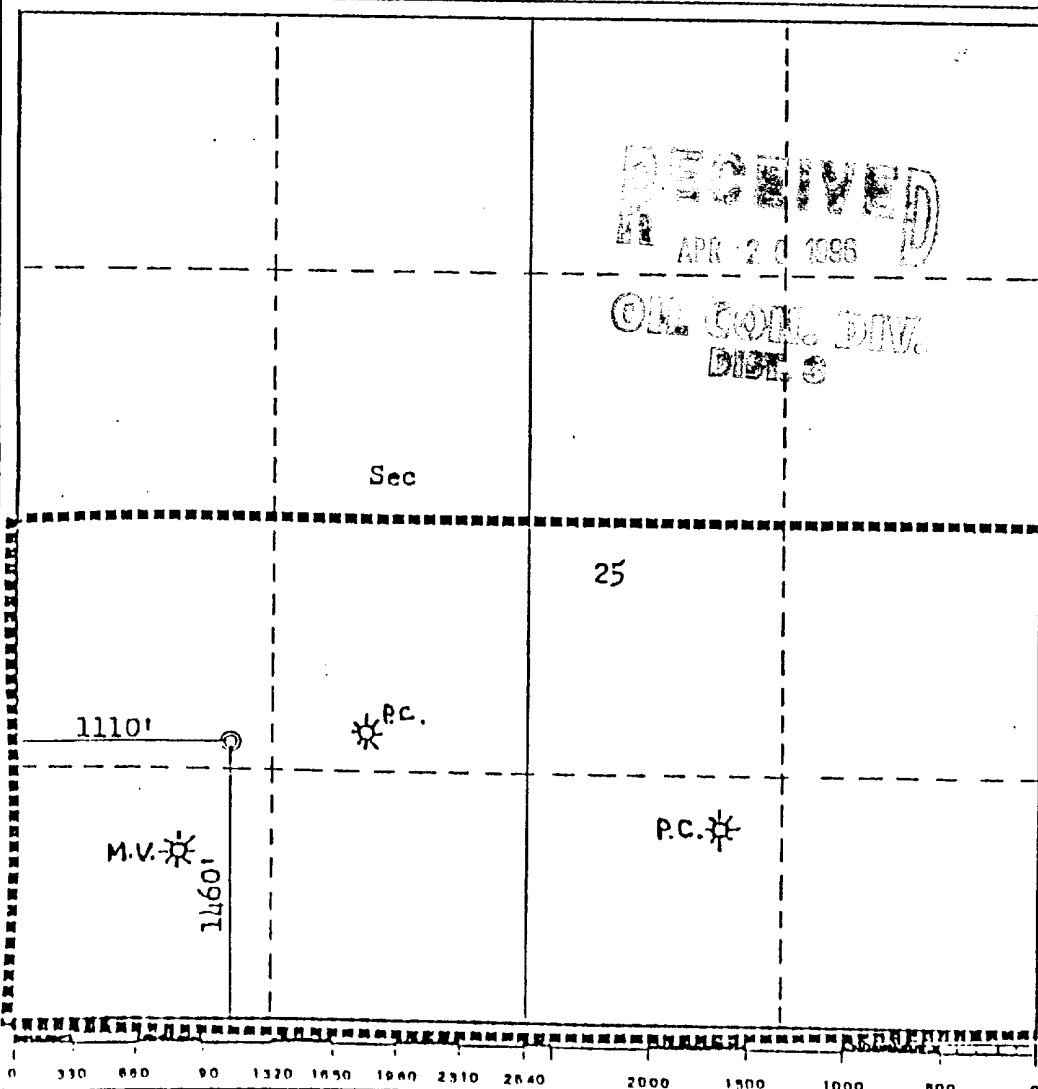

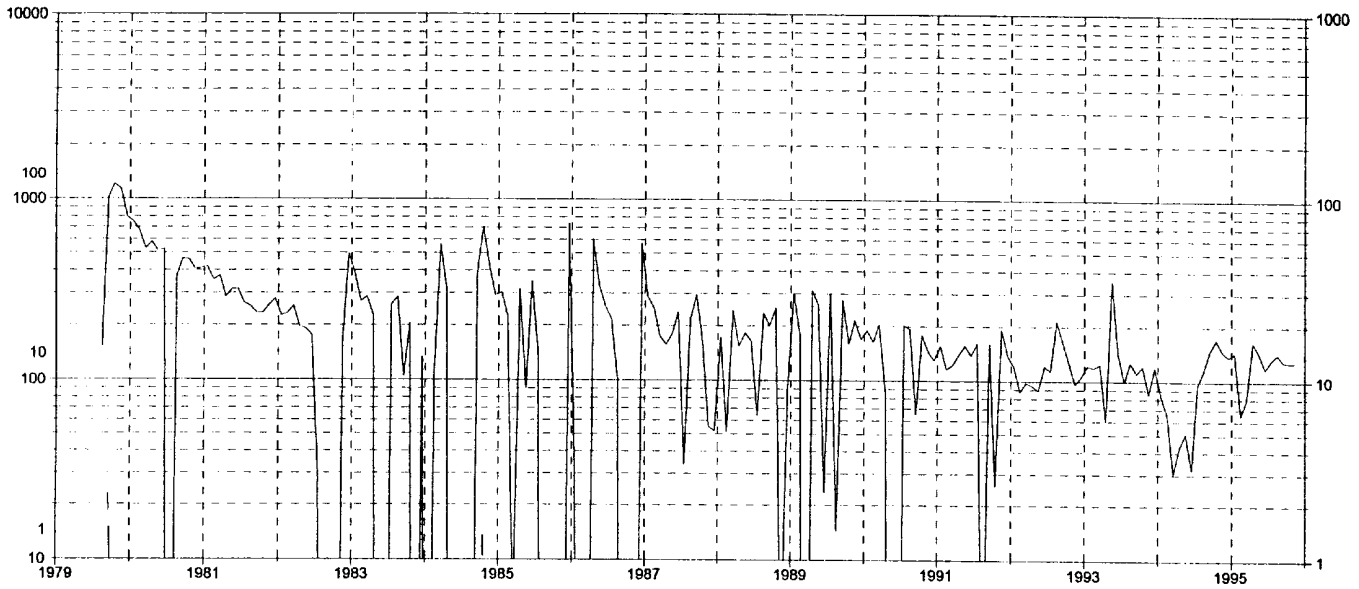

ALLOCATION METHOD
MANSFIELD A #1

The recommended allocation method for the Mansfield A #1 is to extrapolate the existing Dakota decline through the potential economic limit of the well and attribute any excess production after commingling to the Mesaverde recompletion. Attached you will find a tabulated listing of the expected Dakota production through time. Condensate production is expected from both zones and it is recommended that the condensate be split on the same percentage basis as the Dakota/Mesaverde gas production split for that month.

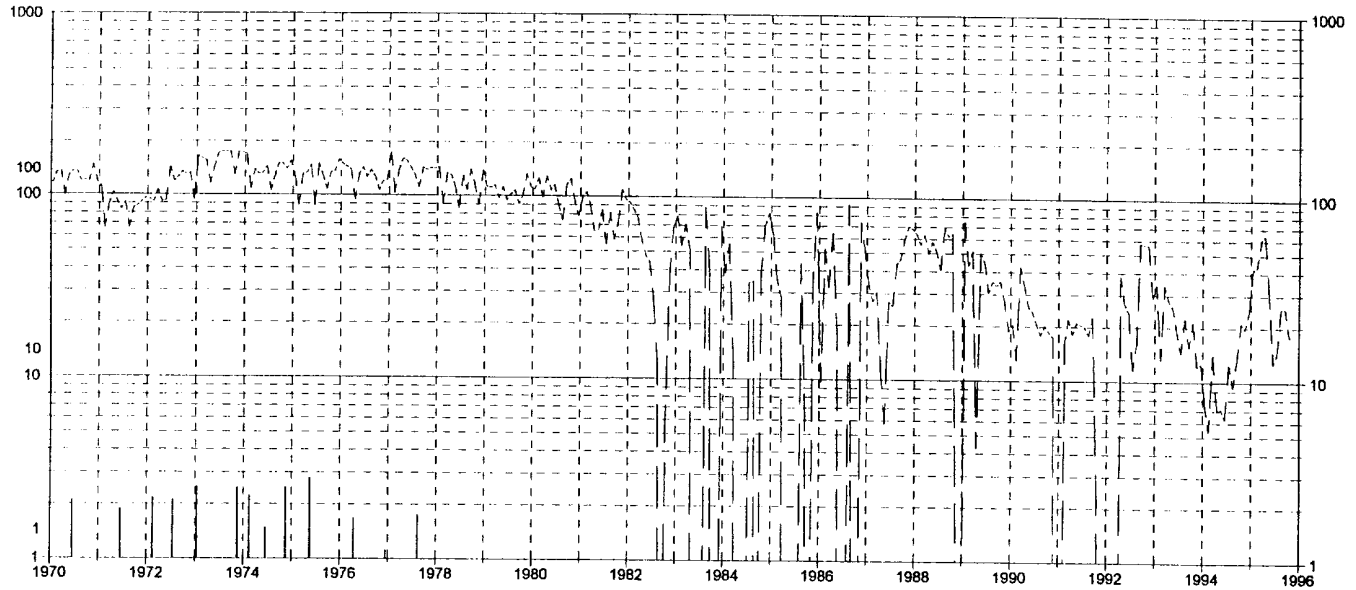
