Spudded 11" hole on 4/20/79. Ran 5 jts 8 5/8", 24#, K-55 csq and set @ 235'. Cemented w/140 Sx class "B" cement, 3% CACL2, 1/4# Sx cello flake. Plugged down, and WOC 12 hrs. RU manifold. Pressure tstd csq to 1000 psi for 15 min-held ok. Reduced hole to 7 7/8" and drilled to T.D. @ 3200' on 4/25/79. Ran electric logs. Ran 77 jts 5 1/2", 15.5#, K-55 csq and set @ 3202'. Cemented w/766 Sx 50/50 poz mix, 4% gel, 1/2 cu. ft. Gilsonite, 1/4# Sx cello flake, followed by 100 Sx class "B" neat cement. WOC 12 hrs. Released rig. WOCU.
