Pressure tstd csg to 1000 psi for 15 min - held ok. Reduced hole to 7 7/8" and drilled to T.D. @ 3075' on 7/17/79. Ran electric logs. Ran 74 jts 5 1/2", 15.5#, K-55 csg & set @ 3074'. Cemented w/550 Sx class "B" 50/50 poz mix, 2% Gel, 6 1/4# Sx Gilsonite, 0.5% CFR-2, followed by 150 Sx class "B" cement w/0.5% CFR-2. WOC 12 hrs. Released rig. WOCU.

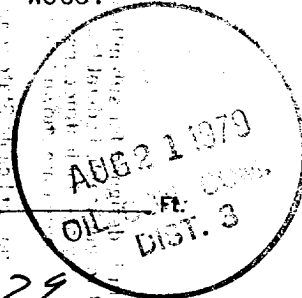
