On August 22, 2000, Amoco Production Company submitted a notice of intent to plug and abandon the subject well. Amoco now request permission to maintain this well as a shut-in well in order to re-evaluate if it is feasible to stimulate and or perform repair operations in order to restore the well to production status in the existing formation or possible recompletion to another pool. We anticipate completion of well review by the end of the 4th QTR of this year. If well review results in possible production opportunity for the well and NOI will be submitted detailing recommended course of action. If no production opportunity exist in the wellbore we will proceed to plug and abandon as per procedure on file.
