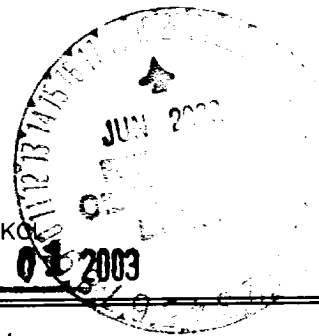
Please reference telephone conversation on May 17, 2002, between representatives of BP America and Steve Mason, BLM and Charlie Perrin, NMOCD, regarding bringing various inactive wells into compliance.

The subject well was approved for plug and abandonment on 09/05/2000. Verbal permission was granted to temporarily abandon the well (or pressure test for casing integrity) in order to bring well into compliance and hold for possible uphole recompleat into the Mesaverde, Pictured Cliffs or Fruitland Coal Formations. After final review, if no future potential exists in the wellbore we will proceed to plug and abandon in accordance with approved plug and abandonment procedures.

We have completed the temporary zone abandonment of the Dakota formation as follows:
