On October 18, 1999, Amoco Production Company submitted a request to maintain the subject well in a shut-in status pending evaluation of possible uphole recompleat. I has since been determined that uphole potential does not exist in the subject well. It is our intention to plug and abandon the wellbore. Plugging procedures are being formulated and will be submitted to your office in approximately 30 days. Plugging operations will be initiated upon regulatory and partner approval.
