By this verified application submitted in triplicate, Manana Gas, Inc. requests approval of an unorthodox location for its Mary Wheeler #2 to be located 892' FSL & 624' FWL of Section 23, T-30, R-12W. Permissible location for a Dakota Well must be at least 790' from the outer boundary line of the 320 acre proration unit.

The reason for the unorthodox location is topographical. We want to drill this well as near as possible to the SW corner of this half section. A 790' location would put us in the middle of the Animas River. Our proposed location would be as near to the river as possible, but still 166' short of meeting 790' FWL minimum requirement.
