Spudded well at 2080 hrs, 03/16/80. Drilled 12 1/4" hole to 268'. Ran 8 5/8" 24# K-55 surface casing and set at 266'. Cemented with 190 sks class "B" + 2% CaCl2 + 1/4# Flocele/sk. Circulated 5 sks of cement. Plug down at 7:00 AM, 03/17/80. WOC 12 hrs, and pressure tested BOP to 800 psi, held OK 30 minutes.
