Plans are to bury a #2 and a #8 guage cathodic cable 12 to 18 inches in the ground from a proposed cathodic line located in the SW1/4 NW1/4, Sec. 34, T.31 N., R.7 W to the NEBU 20A well location, as shown on the attached map. The purpose of this undertaking is to provide cathodic protection for the NEBU 20A well casing. The cable will be routed parallel to an existing Williams Field Service pipeline and will be 10 -15 feet from the pipeline. No right-of-way clearing will be required and the cable will be plowed in with the use of a ripper tooth on a ditch witch. All surface disturbance will be confined to the existing 50 foot right-of-way. An archeological report DCA-535, dated August 3, 1982, was prepared for the pipeline right-of-way (Grant No. NM-53678), and is on file with the Bureau of Land Management. The project will be on Bureau of Land Management lands and will be 4,180. feet in length.
