
Gentlemen:

Joel B. Burr, Jr. requests unorthodox location for his No. 1 Foothills "B" at 1390' FSL and 1650' FEL 20-30N-12W San Juan Co., NM. The Pictured Cliffs was approved as non-standard at this location by NSL-1702. This application seeks approval of the Fruitland formation of this site. The Fruitland will be completed in a common wellbore with the Pictured Cliffs.

The request is based on topography. A pipeline prevents the proper distance from the interior boundary. A plat showing this feature is attached.

All offset operators have been notified by certified mail. A map showing ownership of offset 160'S and all wells completed there-on is attached.


