Union Texas Petroleum wishes to advise that a 8-3/4" hole was drilled to 2705'. Log well. Run 7", 32#, P-110 to 2705'. Cement to surface with 260 sxs (746 cu.ft.) 65/35 POZ with 12% gel and 12-1/4# gilsonite/sk, followed by 100 sxs (118 cu.ft.) Class "B" with 2% CaCl2. Drill 5-7/8" hole with natural gas to 5100'. Log well. Set 4-1/2", 10.5#, 16.9# liner from 2492' to 5100' KB. Cement with 250 sxs (393 cu.ft.) 50/50 POZ containing 4% gel, 6-1/4# gilsonite/sk and 10# salt/sk. Circulate out 13 of 20 bbls of gel water spacer.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
