Union Texas Petroleum wishes to advise that this well was spud at 1:30 P.M. 10/14/87. A 12-1/4" hole was drilled to 368' KB. Run 9-5/8", 36#, K-55 casing to 367' KB, cementing to surface with 205 sx (242 cu.ft.) C1 "B" with 2% Cacl2 and 1/4# flocele/sk. Circulate 6 bbls (34 cu.ft.) of cement to surface. Nipple up BOP and manifold, testing to 1000 psi. Held OK. Test casing to 600 psi. Held OK. Drill 8-3/4" hole out of surface.
