Amoco intends to repair the above well as shown below. Verbal approval to move on the well was obtained from Steve Mason at the BLM on 5/18/89.

1. MIRUSU. Blow down well. Kill if necessary with 1% KCL.
2. NDWH, NUBOP.
3. POOH with tubing.
4. RIH with bit and scraper. POOH.
5. Set 7" RBP at 3600'. Pull one stand and PT RBP to 2000 PSI. Load backside and PT to 750 PSI to confirm leak.
6. Isolate leak. RIH with tubing and spot 12 sx (50') of sand above RBP. Establish rate with fresh water.
7. Squeeze with 100 sx Class B cement with 2% CaCl (with 0.6% D60 in first 75 sx). WOC 24 hours.
8. TOH.
9. RIH with bit and casing scraper. Drill out cement.
10. Pressure test casing to 750 PSI. POOH.
11. Swab test the cement squeeze. Resqueeze if necessary.
12. RIH with tubing and retrieving head. CO to RBP with foam. Release RBP and POOH.
13. RIH with tubing and with SN 1 jt off bottom. Land tubing at 6025'.
14. NDBOP. NUWH. Kick well around with nitrogen. RDMOSU.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
