As discussed with Jim Jacobs of your company on October 18, 1990, the subject APDs are rescinded and returned due to drilling not being commenced within one year of the approval date and within the second six month extension period.

Your are required to request surface rehabilitation instructions from this office if construction activities occurred on the referenced drill site. If this office has not received comment within 30 days, it will presume that no construction occurred and proceed accordingly. Later discovery that construction activities have in fact occurred, may result in assessment of liquidated damages.
