11-16-88 Spudded well at 8:30 pm 11-16-88. Drilled to 237'. Ran 5 jts. 9 5/8", 32.3#, H-40 surface casing set at 237'. Cemented with 150 sks. Class "B" with 1/4#/sk. gel-flake and 3% calcium chloride (177 cu.ft.). circulated to surface. WOC 12 hrs. Tested 600#/30 minutes, held ok.

11-20-88 TD 3190'. Ran 74 jts. 7", 20.0#, K-55 intermediate casing, 3177' set @ 3190'. Cemented with 100 sks. Class "G" w/2% calcium chloride (115 cu.ft.) followed by 390 sks. Class "G" 65/35 with 6% gel, 2% calcium chloride, 1/2 cu.ft. perlite/sx (768 cu.ft.), followed by 100 sx. Class "B" with 2% calcium chloride (115 cu.ft.). WOC 12 hours. Held 1200#/30 min. Circulated to surface.
