Blackwood & Nichols proposes to construct a 6" diameter temporary surface pipeline along our pipeline right-of-way from the NEBU #455 to a point 1.22 miles west of the NEBU #455, at which point natural gas powered 1400 HP compression will be set. A second 6" diameter temporary surface pipeline will be constructed along .23 miles of our pipeline right-of-way from the NEBU #473 to the same compression site. The surface lines and compressor will be removed within 12 months.
