Reference is made to your application of January 24, 1989 for a non-standard coal gas well location for your Northeast Blanco Unit Well No. 414 to be located 2330 feet from the North line and 150 feet from the East line (Unit H) of Section 30, Township 31 North, Range 7 West, NMPM, Basin Fruitland Coal (Gas) Pool, San Juan County, New Mexico. 
The east half of Section 30 will be dedicated to this well. All offset proration units are operated by Blackwood and Nichols Co., Ltd.


