

Re-cavitation operations commenced on 7-25-01 and ended on 8-30-01. Pressure tested 7" casing before operations began. The 5-1/2" uncemented liner was installed and perforated with 4 SPF from 3054' to 3204' with a total of 600 holes. Top of liner hanger at 3009'. Bottom of liner bit shoe at 3210.79'. 2-3/8" tubing set at 3175'.
