Propose to spud in the San Jose formation. Will drill a 12-1/4" surface hole to a TD of 400'. Surface casing will be run and cemented with cement returns to surface. WOC 12 hours. Test to 600 psi/30 minutes. Drill an 8-3/4" hole to a TD of 2924' using fresh water mud. No poisonous gasses or abnormal pressures are anticipated. Run intermediate casing and cement with cement returns to surface. WOC 12 hours. Test to 1500 psi/30 minutes. Drill a 6-1/4" hole to a TD of 3108' using water and air. Run a mud logging unit while drilling this interval. Run the production liner. The liner will be cemented if the well's natural flow capacity indicates the need for fracture stimulation.

Surface ownership is Bureau of Land Management.
