Devon Energy proposes to clean out and remove 5 ½" liner. Pressure test 7" casing to 500 psi. Under-ream open hole. Re-cavitate open hole and remove near well bore coal material. Re-install 5 ½" liner. Use a 24 hour rig (open hole) package (rig time estimate: 15 days) and surge well during the night.
