Plug #1 with ret @ 3374', spot 41 sxs Class B cmt inside csg above CR up to 2834' to cover Fruitland Coal. R. Snow with BLM, required setting tool be removed & additional cmt on Plug #2. TOO H w/tbq & setting tool. TIH open-ended to 2880'. Plug #2 w/20 sxs cmt inside csg from 2280' to 2016' to cover Kirtland & Ojo Alamo tops. PUH to 812'. Shut-in well. SDON.

2/27/02 Plug #3 w/43 sxs cmt inside csg from 812' to 245' to cover Nacimiento top & sidetrack window. TOO H. Perf 3 sqz holes @ 50'. Est circ out bradenhead. Plug #4 w/36 sxs cmt pumped down 4-1/2" csg from 50' to surface, circ good cmt out bradenhead. Dig out WH. ND BOP. Cut off WH. Found cmt down 5' in 9-5/8" csg & down 5' in 7" csg & at surface in 4-1/2" csg. Mix 20 sxs cmt to fill csg & then install P&A marker. RD. Rig released.
