13. Describe Proposed or Completed Operations

It is intended to recavitate the subject well in the following manner:

Pull the production tubing. Pull the 5 1/2" liner. Cavitate the Fruitland Coal formation utilizing natural and air assisted surges until the well stabilizes. Clean the well to total depth and run a 5 1/2" 15.5# K-55 casing liner. The liner will be pre-perforated with 4 shots per foot across the coal intervals. Rerun the production tubing. The well will then be returned to production.
