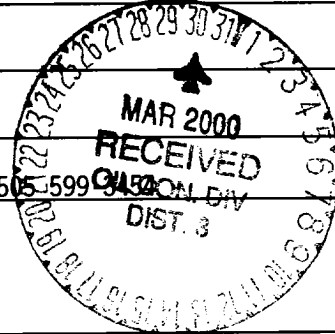

3. Rotor set with 132 rods (7/8"). 2 - 4' Subs & 4 Snap-on rod Guides per first 4 rods. Rotor set down in stator @ 3330'.
