2-7/8" R Nipple @ 3547'.
2-7/8" F Nipple @ 3202'.
Lok-set Packer top @ 3246' & bottom @ 3242'.
On/off tool @ 3236'.

ND BOPs & NU WH. RD & MO 8/29/97. Returned well to production.
