8/20/97 MIRU Big A #18. ND WH & NU BOPs. Test- OK. Killed well. COOH w/production tubing. RIH with the following:

2-7/8" tubing set @ 3510'

2-7/8" R nipple set @ 3478'

Packer top @ 3231' and bottom 3234'

On/off tool @ 3225'

ND BOPs & NU dual WH. PT - OK. RD & MO 8/22. Returned well to production.
