MIRU Big A #19 to pull liner, recavitate & stimulate well. ND WH & NU BOP's. Test BOP's. COOH w/2-3/8" Eue 8rd tubing. TIH w/3-1/2" DP, & 4-3/4" BHA w/fishing tool. Spear into 5-1/2" liner @ 3162'. COOH w/3-1/2" DP, 4-3/4" BHA, fishing tools, & 5-1/2" liner. Laying down 7 jts of 5-1/2" perf'd liner. Cleaned out to TD @ 3409'. Rotate & Reciprocate w/2.1 mmcf/d air & 10-12 bph water w/5-10 bbl water sweeps every 30 min. Surged well w/500# to 1000# psi air w/5 bbls stages of water to breakdown coal seams. Continuously rotated & reciprocated with air & water, cleaning out to TD.

LD DP & DC. TIH w/2-3/8" Eue tubing, set expendable check @ 3305', F Nipple w/1.81 profile set @ 3273'. Landed hanger w/BPV in place. RD BOP's & RU WH. Test to 3000 psi. Pull BPV. Pumped check. RD & released rig @ 6:00 am 11-29-94.
