Spud a 12 1/4 surface hole on 12-12-90 at 12:30 hrs. Drilled to 270 '.

Set 9 5/8" 36# K-55 surface casing at 270 '. Cemented with 220sx class B Adhesive. Circulated 12 BBLs to the surface. Pressure tested casing to 1000 psi. Drilled a 8 3/4 " hole to a TD of 2763 ' on 12-14-90. Set 7" 23# K-55 production casing at 2703 '. Cemented with 475sx class G Dowell 65/35 per, tail with 100sx class G Dowell. Circulated 34 BBLs good cement to the surface.

Any necessary special in-

structions concerning the use of this form and the number of copies to be submitted, particularly with regard to local area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

SPECIFIC INSTRUCTIONS
