The well will be completed in the Fruitland Coal with a fracture stimulation.

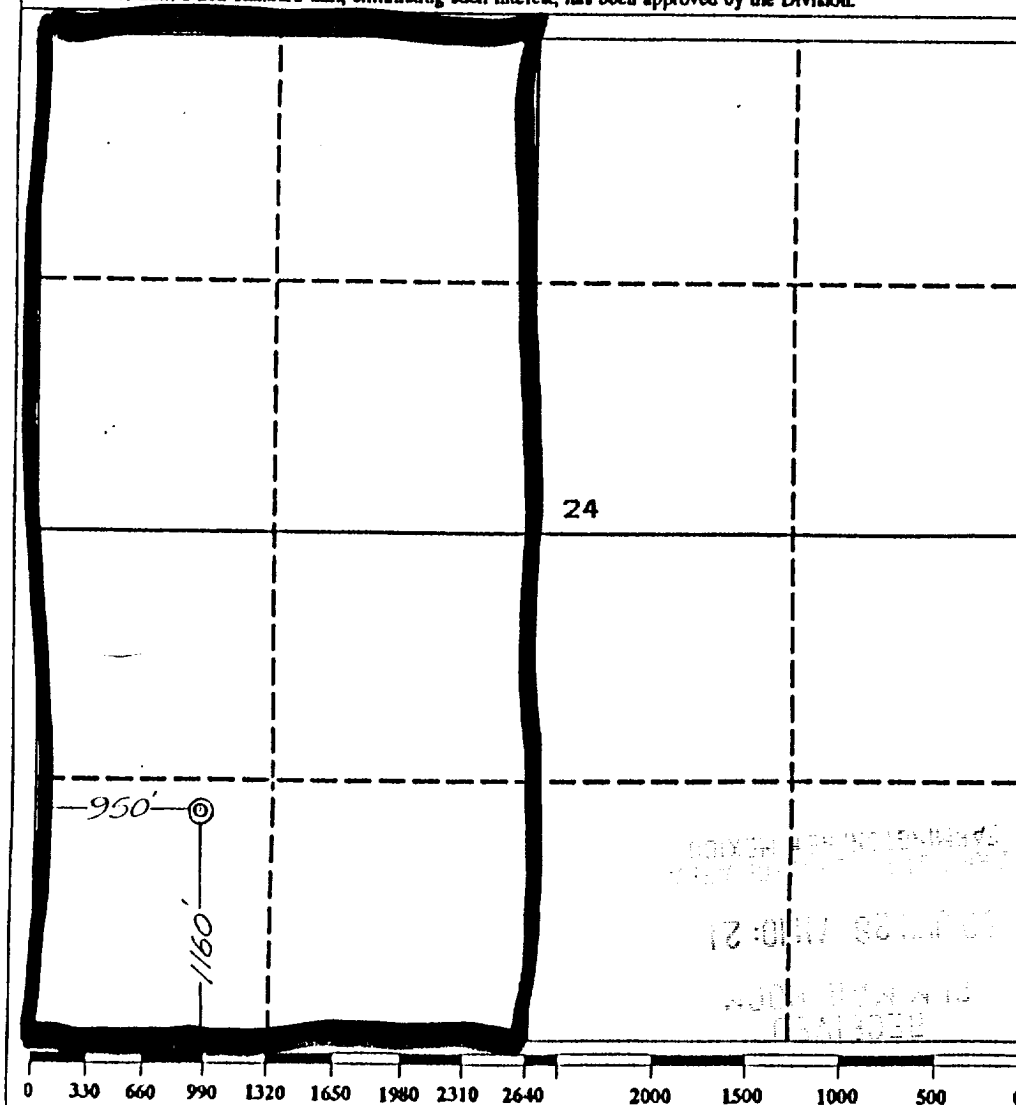

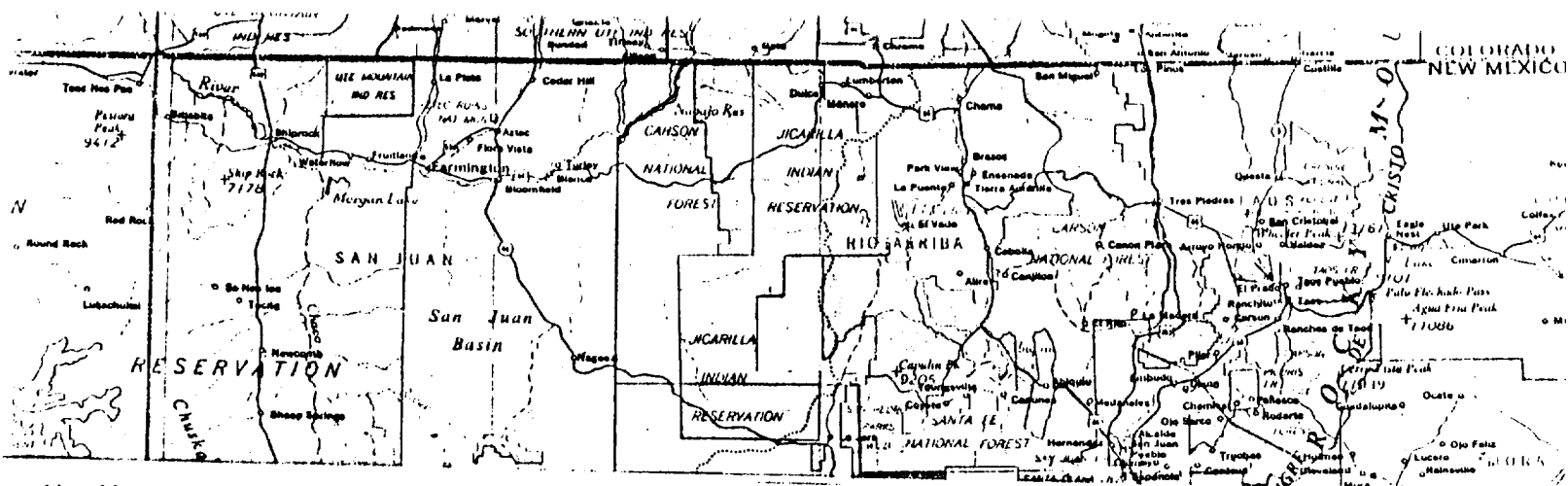
