Moved in & rigged up Four Corners Drilling Co. Rig #14. Spudded a 12½" hole at 4:15 10-7-92. Drilled to 235' RKB. Ran 5 jts., 8-5/8" OD, 24#, 8 Rd, ST&C casing (T.E. 218') set at 230' RKB. Cemented with 135 sx class "B" + 2% CaCl₂ (total cement slurry = 159 cu.ft.). Circulated approximately 4 bbls cement to surface. P.O.B. @ 10:30 P.M. 10-7-92. W.O.C.

(Note: After nipping up to drill and while W.O.C. tested surface casing and BOP 1000 psi for 30 minutes -held OK.)
