09-30-97 Ran 59 joints 7", 23# K-55, 8rd Lt & C, casing, landed @ 2673'. Cement with 350 sks - Class B 35/65 POZ with 8% GcL, 2% CaCL-2, .25#/sk Cello Flake, 6.25lb/sk Gilsonite. 115 sks Class B w/ 2% Cacl-2, .25#/sk Cello Flake. Displaced with 103.9 bbls of water.
