GIH w/6-1/4" bit & tagged cement @ 3083'. Drilled out cement, then drilled new formation from 3148' - 3481' (TD). TD reached 6/5/99. COOH. RIH w/underreamer and underreamed 6-1/4" hole to 9-1/2" hole from 3148' to 3481'. Circulated hole. COOH. Rotated and reciprocated w/air and water sweeps and then surged well for approx. 11 days, cleaning out to TD. GIH w/5-1/2" 15.5# J-55 casing (liner) and set @ 3490'. Top of liner set @ 3082'. Total 408' of liner.

RU Blue Jet & perf'd .75" holes @ 4 spf as follows:

3184' - 3198' (14'); 3250' - 3266' (16'); 3272' - 3286' (14') 3352' - 3362' (10')
3466' - 3473' (7') Total 61' = 244 holes

RD Blue Jet. RIH w/2-3/8" 4.7# J-55 tubing and set @ 3445' with "F" nipple set @ 3414'. ND BOPs & NU WH. PT to 200 for 3 minutes, then 2000 for 10 minutes. OK. Pumped off check. RD & released rig 6/17/99. Turned well over to production department.
