

Run GR-CCL-CNL from PBTD (1201') to surface. Perforate Fruitland Coal 1011'-18', 1035'-40', 1050'-55' (total 20 holes); 1098'-1108', 1112'-18' (total 64 holes). Acidize with 675 gals 15% HCL. Frac Fruitland Coal with 60,000# 20/40 sand in 40,500 gals foam.
