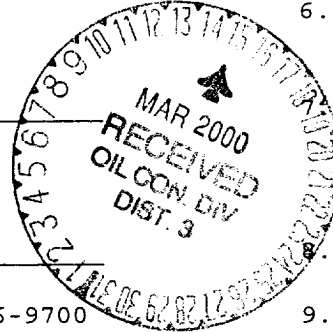

2-13-00 TOOH. TIH w/5 jts 7# 23# N-80 LT&C & 82 jts 7" 20# J-55 ST&C csg, set @ 3654'. Stage collar set @ 2768'. Cmdt 1st stage w/146 sx Class "B" neat cmt w/2% sodium metasilicate, 2% calcium chloride, 0.25 pps cellophane, 5 pps kolite (254 cu ft). Circ 16 bbl cmt to surface. Cmdt 2nd stage w/276 sx Class "B" neat cmt w/0.25 pps cellophane, 5 pps kolite, 6% gel, 2% calcium chloride (839 cu ft). Circ 6 bbl cmt to surface. WOC. NU BOP. PT BOP & csg to 1500 psi/30 min, OK. Drilling ahead.
