- 5-1-00 MIRU. ND WH. NU BOP. TIH w/CIBP, set @ 4350'. RU W/L. Chemical cut 5 1/2" csg @ 2450'. TOOH w/5 1/2" csg. Ran GR-CBL-CCL @ 2450'-surface. TOC @ 410'. Perf 2 sqz holes @ 350'. RD W/L. TIH w/pkr, set @ 264'.
- 5-2-00 (Verbal approval from Jim Lovato, BLM, no squeeze & patch 5 1/2" csg to surface) PT lines to 3000 psi, OK. Attempt to brk dwn sqz holes w/1000 psi. Cannot pump into. Rls pkr & TOOH.
