11-30-00 TIH w/68 jts 7" 23# J-55 LT&C csg, set @ 2835'. Cmdt w/308 sx Class "G" neat cmt w/2.5% sodium metasilicate, 2% calcium chloride, 10 pps gilsonite, 0.5 pps cellophane, 0.1% antifoamer (795 cu ft). Tail w/90 sx Class "G" 50/50 poz w/2% gel, 2% calcium chloride, 0.25 pps cellophane, 0.5 pps gilsonite, 0.1% antifoamer, 30 pps litepoz 7 (115 cu ft). Circ 75 bbl cmt to surface. WOC. PT BOP & csg to 1500 psi/30 min, OK. Drilling ahead.
