INSTALL AC POWER RECTIFIER AND FLOW IN THE ROADWAY APP. 18" TO 24" DEEP, UNDERGROUND AC POWER USING #8 CABLE FROM EXISTING UGAC GOING TO THE QUINN 2A. ALL WORK WILL BE PERFORMED ON PREVIOUSLY DISTURBED GROUNDS AND WITHIN THE LOCATION BOUNDARY.
