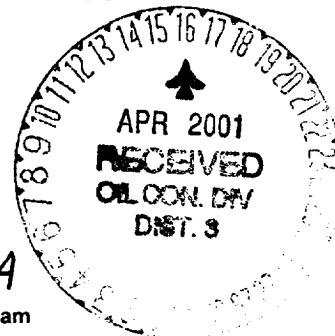

ALL WORK TO BE PERFORMED ON LOCATION, PLROW'S, OR ROADWAYS IN PREVIOUSLY DISTURBED GROUNDS. UGAC IN ROADWAY FROM SUNRAY F 1, NEGATIVE CABLE TO SUNRAY F 5 PAD TO PAD.
