On 11/7/00 Cross timbers set 5 jts of 7", 20#, J-55 surface casing @ 224' KB. The surface casing was cemented with 75 sx Type III cement. 7 bbls of good cement was circulated to surface.

On 11/8/00 the BOP stack was installed and pressure tested and drilling resumed.
