17. Describe Proposed or Completed Operations (Give Pertinant Details and Dates.)

Change casing program to:

Drill 8-3/4" hole to 130'.

Run 7" 20 #/ft surface casing to 130', circulate cement using 40 CuFt, 35 sx Class B cement w/0.25# Flocele/sx plus 3% CaCl.

Drill 6-3/4" hole to 2400'.

Run Logs, including a caliper survey.

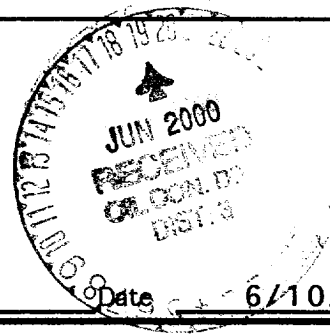
Run 4-1/2" 10.5 #/ft production casing to 2400', circulate cement using 230 CuFt, 115 sx, lite cement w/ 2% metasilicate, 0.25 pps Flocele and 2% CaCl followed by 77 CuFt, 65 sx, standard w/0.6% Halad-322 mixed to 15.6 ppg w/ caliper plus 25% excess in both slurries. Totals: 307 CuFt, 180 sx.

Run Cement Bond Log before perforating any zones for completion to confirm top of cement and bonding throughout production string from TD to surface.
