

Cross Timbers Operating Company hereby requests administrative approval for an unorthodox location for the above referenced well. Attached for your reference are the following exhibits:

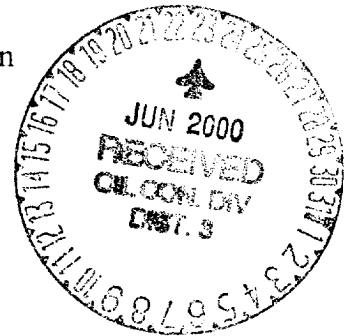
1. Well location plat (NMOCD Form C-102)

The above captioned well will be proposed to test the Basin Dakota Formation. The well spacing would be a W/2 Unit consisting of approximately 320 acres. The rules state that the well should not be closer than 790' to any quarter section line, nor closer than 130' to any quarter-quarter section line. The well is unorthodox because it will not conform to the current footage requirements at the proposed location. It is necessary to drill the well in an unorthodox location due to the surface topography.
