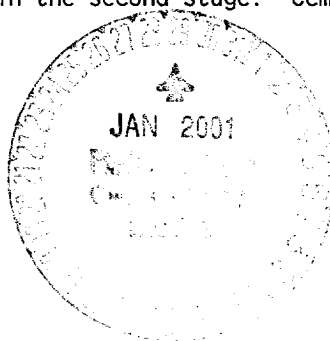

Cross Timbers Operating Co. reached a TD of 5,260' KB on 11/10/00. ON 11/13/00 Cross Timbers set 125 jts 4-1/2" casing @ 5,243' KB. The casing was cemented in two stages using 310 sx cmt (648 cuft) in the first stage and 550 sx (1,150 cuft) cement in the second stage. Cement was circ to surface on both stages. The rig was released on 11/14/00.
