01/19/01 Well spudded.

01/20/01 – Ran 12 joints of 7" (20#, J-55) casing, set shoe at 512', hole size is 8-3/4". Cement with 130 sks (32 bbls) Type III cement with 2% CaCl and 0.25 pps Cello Flake. Displaced with 20 bbls fresh water returned 9 bbl to surface. Bumped plug with 190# psi at 5:15 am.

01/22/01 – Ran 49 joints of 4-1/2" (10.5#, J-55) casing, set shoe at 2085', hole size is 6-1/4". Cement with 200 sks (70 bbls) of 65:35 with 6% Gel, 7pps CSE, 2% CD-32, 0.25 pps Cello Flake, and 0.65% FI-62. Displaced with 32 bbls 2% KCl, returned 15 of the 20 bbl spacer, late pressure was 590#, no cement. Bumped plug with 1350# psi at 11:00 am. Floats held.
