01/12/01 - Ran 15 joints of 7" (20#, J-55) casing, set shoe at 602', hole size of 8-3/4". Cement with 140 sx of Type III cement with 2% CaCl and 0.25 pps Cello Flake. Displaced with 24 bbls fresh water returned 16 bbls to surface. Bumped plug at 2:00 pm with 150# psi, floats held.

01/15/01 - Ran 53 joints of 4-1/2" (10.5#, J-55) casing, set shoe at 2230', hole size is 6-1/4". Cement with 180 sx of 65:35 with 6% Gel, 7 pps CSE, 2% CD-32, 0.25 pps Cello Flake and 0.65% FL-62. Displaced with 35 bbls 2% KCl, returned 8 bbls to surface. Bumped plug at 2:05 am with 1750# psi, floats held.
