01/04/01 Ran 16 joints of 7" (20#, J-55) casing, set shoe at 668', hole size 8-3/4". Cement with 150 sk Type III cement with 2% CaCl and 0.25 pps Cello Flake. Displaced with 25.3 bbls freshwater, returned 15 bbls to surface. Bumped plug at 2:00 pm with 150# psi. Floats held.

01/06/01 Ran 57 joints of 4-1/2" (10.5#, J-55) casing, set shoe at 2230', hole size 6-1/4". Cement with 170 sk 65:35 with 6% gel, 7 pps CSE, 2% CD-32, 0.25 pps Cello Flake and 0.65FL-62. Displaced with 34.7 bbls 2% KCl, returned 10 bbls to surface. Bumped plug at 7:45 pm with 1000# psi, floats held.
