RIH w/8-3/4" bit & tagged cement @ 300'. Drilled cement to 336' and drilled ahead 3380'. RIH w/7" 20#, J-55 casing and set @ 3376' with ECP set @ 2713' to 2692' and 7" stage tool set @ 2692' - 2689'.

RU to cement. Pumped 10 bbls mud clean, 10 bbls FW w/red dye ahead of 1st stage Lead - 80 sx (190 cf - 33.9 bbl slurry) Type 3, 35/65 POZ cement w/6% gel, 1/4#/sx Cello-flake, 5#/sx CM-1, 10#/sx CSE, 0.4% FL-25 & 0.02# static free. Tail - pumped 50 sx (70 cf - 12.5 bbl slurry) Type 3 cement w/1% CaCl2 & 1/4#/sx Cello-flake. Displaced w/135 bbls FW. Bumped plug to 500#.

Pumped 2nd stage. Pumped 10 bbls mud clean, 10 bbls FW w/red dye, then pumped 360 sx Type 3, 35/65 POZ w/6% gel, 1/4#/sx Cello-flake, 5#/sx LCM-1, 10#/sx CSE, 0.4% FL-25 & 0.02#/sx Static Free. Pumped tail - 50 sx (69.6 cf - 12.4 bbl slurry) Type 3 with 1% CaCl2, & 1/4#/sx Cello-flake. Dropped plug & displaced w/109 bbls FW. Bumped plug to 1500#. Circ. 12 bbls cement to surface. WOC.

ND BOP, set slips & cut off 7" casing. NU BOP, lines and manifold. PT casing, rams and manifold to 200# 3 minutes and then 3000# 10 minutes. Good test.
