4/10/01 RU CUDD's coiled tubing unit. RIH w/mill on coiled tubing and tagged up @ 4886'. Drilled cement to 4950'. Drilled out DV tool and tagged down to 5698'. Rolled hole w/2% KCl. COOH. RD CUDD. RU Blue Jet and ran CBL & GSL. TOC @ 2650'. PT casing to 500 psi for 20 minutes and then 3000 psi for 10 minutes. Good test. Perforated Pt. Lookout @ 1 spf .34" holes as follows: 5517', 5450', 5434', 5430', 5414', 5412', 5402', 5398', 5390', 5386', 5344' total 11 holes

Perforated Menefee & Cliffhouse @ 1 spf .34" holes as follows: 5303, 5271', 5238', 5098', 5066', 5062', 5054', 5049' Total 8 holes

Acidized perfs w/1000 gal 15% HCl. RU to frac. Pumped 321 bbls 2% KCl slickwater, 893 bbls 2% KCl slickwater foam, flushed w/22 bbls 2% KCl. Total sand 17,140 # 20/40 Brown sand & total N2 - 2,345,000 scf w/70% Quality foam. Flowed back on 1/4" and 1/2" chokes. RD flowback equipment.

Turned well over to production to flow test well, flowing through casing valves. Will test without tubing for 60 days and then return and add the Lewis Shale & run tubing and put back on line.
